INSTRUCTIONS TO BIDDER

SECTION - A

1. The General Manager (Drugs), Tamil Nadu Medical Services Corporation Limited invites quotations from the **Manufacturers / Distributors having valid License / Manufacturers authorization** for the supply of **Disposable Safe Delivery Kit** to Tamil Nadu State AIDS Control Society for the listed items in the **Annexure-I**.

2. Qualification of the bidder: The bidder shall provide qualification information, which shall include:
 - (A) Manufacturing license/ Import License for the item quoted as applicable.
 - (B) For distributors, wholesale license for the sale along with manufacturer's Authorization and manufacturing license / import license of the company with endorsement copy for Product quoted.
 - (C) Average annual turnover for the last 3 years (i.e., 2015-2016, 2016-2017 and 2017-2018).
 - (D) Kits supplied should bear the logo "TN Govt. Supply Not For Sale" in the cartons and it may be affixed/printed with indelible ink.

3. **BID PRICE**
 - a) Contract shall be for the supply of Disposable Safe Delivery Kit to the Tamil Nadu State AIDS Control Society, Corrections if any made in the rates shall be done by crossing out, initialing, dating and re-writing.
 - b) The rate quoted per unit for landed price shall be inclusive of freight, Insurance, customs duty but exclusive of GST.
 - c) The rates quoted by the bidder shall be fixed and shall not be subject to adjustment on any account.
 - d) Rates should be quoted in Indian Rupees only.

4 **SUBMISSION OF QUOTATIONS**

- 4.1 Each bidder shall submit only one quotation.
- 4.2 The quotation submitted by the bidder shall comprise the following:
- a) Quotation in the format given in Section B.
 - b) Qualification information form given in Section B duly completed.
 - c) EMD in the form of Bankers Cheque/Demand Draft for **Rs.10,000/-** drawn in favour of TamilNadu Medical Services Corporation Ltd., Chennai. **(failing which the quotation will be rejected summarily)**
- 4.3 The bidder shall seal and submit the quotation in an envelope addressed to the General Manager, Tamil Nadu Medical Services Corporation Limited, Egmore, Chennai – 600 008.

The envelope will also bear the following Identification:

- 4.4 Quotations must be received in the office of the Tamil Nadu Medical Services Corporation Limited not later than the time and date given in the letter of invitation. If the specified date is declared to be a holiday, quotations shall be received up to the appointed time in the next working day.

4.5 Any quotation received by Tamil Nadu Medical Services Corporation Limited after the deadline for submission of quotations will be rejected and returned unopened to the bidder.

4.6 Quotations should accompany with 3 sets of disposable safe delivery kits for evaluation by TNMSC Ltd. / appropriate authorities.

5. **VALIDITY OF QUOTATION**

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

6. **OPENING OF QUOTATIONS.**

Quotations will be opened in the presence of bidders / authorized representatives who choose to attend on the date and time and at the place specified in the letter of invitation.

7. Information relating to evaluation of quotations and recommendations for the award of contract shall not be disclosed to bidders or any other persons not officially concerned with the process until the award to the successful bidder is announced.

8. **EVALUATION OF QUOTATIONS**

The purchaser will evaluate and compare the quotations determined to be substantially responsive as indicated below.

- (A) Meet the qualification criteria specified in clause 2.
- (B) Are properly signed
- (C) Conform to the terms and conditions and specifications.
- (D) The quotation would be evaluated for an individual schedule.
- (E) Rates to be quoted only in **Annexure - III**.
- (F) 3 sets of samples should be submitted on the day of opening of Quotations for evaluation, failure to submit samples leads to not consideration of the bid.

9. **AWARD OF CONTRACT**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price and who meets the specified qualification criteria.

9.1 Notwithstanding the above, the Tender Inviting Authority reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at time prior to the award of contract.

9.2 The bidder whose bid is accepted will be notified the award of contract by the Tender Inviting Authority prior to expiration of the quotation validity period.

10. **SUPPLY SCHEDULE**

10.1) The supply shall be made to the destinations as in the Annexure along with purchase order. The supply should be completed within 30 days from the date of purchase order. If no supply is received even after 45 days from the purchase order, such orders stand cancelled automatically and TNMSC reserves the rights to purchase from alternate source at the risk and cost of defaulted supplier.

10.2) Samples from each batch of supplies will be chosen at the point of supply or distribution/storage points for testing. The samples will be sent to different laboratories for testing as decided by the TNMSC. In case of quality failure the value of the entire batch of the drug will be deducted from any amount payable to the tenderer.

11. **LIQUIDATED DAMAGES AND UNEXECUTED PENALTY:-**

(i) For delay in supply of the goods beyond the stipulated period, liquidated damages at 2.5% per week or part thereof, subject to a maximum 5%.

- (ii) After 45 days from the date of purchase order, unexecuted fine of 10% will be levied for the unexecuted quantity

12. SECURITY DEPOSIT & AGREEMENT :

12.1) On information of acceptance, the successful bidder shall execute agreement with TNMSC and deposit the security amount in the form of Demand Draft in favour of TNMSC Ltd., for 5% of total contract value, failing which the EMD Submitted by the firm will be forfeited.

12.2) If 100% of the ordered quantity is not supplied, the Security Deposit (SD) will be forfeited.

WHEREAS the Purchaser is desirous that certain Goods and ancillary services viz; Supply of **Disposable Safe Delivery Kit** to Tamil Nadu State AIDS Control Society in the tender reference No.**Q001/M(P)/SAFE DELIVERY-KIT/TNMSC/2019, Dt.06.03.2019** (Brief Description of Goods and Services) and has accepted a bid by the Supplier for the supply of those goods and services for the sum of(Contract Price in Words and Figures) (hereinafter called "the Contract Price").
