### ORDER:

In the G.O first read above the Managing Director, Tamil Nadu Medical Services Corporation was permitted to call for the tender and finalize the rate contract for the procurement of Surgical Instruments and appliances to Government Medical Institutions under Central Purchase Committee rates for the period from 01.04.2009 to 31.03.2011.

2. In the G.O second read above Government have issued orders extending the validity of present CPC rates approved by the Managing Director, Tamil Nadu Medical Services Corporation for the Surgical instruments, appliances etc pursuant to the orders issued in G.O.(D).No.1170, Health and Family Welfare (H2) Department, dated 03.11.2009, for a further period of six months upto 30.09.2011 to enable the Medical Institutions to procure the essential items from the list during the period, from the approved suppliers who are willing to extend the validity upto 30.09.2011.

3. The Managing Director, Tamil Nadu Medical Services Corporation has now stated that to finalize the rate contracts for the year 2011-2013 it has been decided to evolve a suitable methodology for finalizing the list by forming 2 separate committee consisting of Specialist to finalize the specification and to do scrutiny, evaluation, etc. Hence the proposal of extending the validity of the present CPC rates further upto 30.09.2011 has been discussed in the 91<sup>st</sup> Board meeting held on 24.02.2011 and the Board resolved to recommend to the Government for such extension. The rate extended in the G.O(Ms) No. 140, Health and Family Welfare Department dated: 20.05.2011 upto 30.09.2011 as per the request of Tamil Nadu Medical Service Corporation. Since the finalization of the rate contract is in process and yet to be completed, the subject was placed in the 95<sup>th</sup> Board meeting held on 25.08.2011 for discussion. The Board resolved

to recommend to the Government for the extension of validity of rate contract upto 31.12.2011.

4. The Managing Director, Tamil Nadu Medical Services Corporation has therefore requested the Government to issue an amendment to the G.O.(Ms).No.140, Health and Family Welfare (H2) Department, dated 20.05.2011, for extending the validity of the present CPC rates further upto 31.12.2011, to enable the Medical institutions to procure the essential items from the list during this period, from the approved suppliers who are willing to extend the validity upto 31.12.2011.

5. The Government after careful consideration, have decided to accept the proposal of the Managing Director, Tamil Nadu Medical Services Corporation. They accordingly extend the validity of present CPC rates approved by the Managing Director, Tamil Nadu Medical Services Corporation for the Surgical instruments, appliances etc pursuant to the orders issued in G.O.(Ms).No.140, Health and Family Welfare (H2) Department, dated 20.05.2011, for a further period of three months upto 31.12.2011 to enable the Medical Institutions to procure the essential items from the list during the period, from the approved suppliers who are willing to extend the validity upto 31.12.2011.
